### Man held for flying drone near CM's event



A man was briefly detained on Tuesday for allegedly flying a drone near Connaught Place while Chief Minister Rekha Gupta was attending an event in the area, a police source said. "The man was detained for some time and was later released after being made to understand that drone is not allowed for the time for security reasons of Independence Day," said the source. The source said that while Gupta was attending a programme, police deployed for security noticed a drone hovering in the vicinity and accosted its operator. It turned out that the detained man was part of the chief minister's media team. Delhi Police Commissioner S B K Singh had on August 2 ordered a ban on sub-conventional aerial platforms across the national capital till August 16 because of Independence Day. The ban covers paragliders, para-motors, hang-gliders, UAVs (Unmanned Aerial Vehicles), UASs (Unmanned Aircraft Systems), microlight aircraft, hot air balloons, small-sized powered aircraft, quadcopters and remotely piloted aircraft.

### Delhi Assembly premises to be open for public

Delhi Assembly premises will be open for people on August 14 and August 15 on the occasion of Independence Day, according to an official statement issued on Tuesday. A Border Security Force (BSF) band will play patriotic tunes, and a cultural performance will also be held to mark the occasion, it said. People will be allowed to visit the Vidhan Sabha building between 5 pm and 8 pm on August 14 and August 15, and will get a tour of historical sites on the premises, the statement said. No registration will be required for the visit on both days, and proper identity cards have to be shown for entering the Assembly premises.

Addressing the participants, the Chief Minister said the true glory of the national flag will be realised when girls achieve complete freedom and that her Government is committed to securing a better future for them.

She added that the time has now come to "empower our daughters." Despite the light rain, the girls successfully completed their ride to Rajghat. Delhi's Education Minister Ashish Sood, was present.

In her interaction with the girls, the Chief Minister said that in the past, the nation

first emphasised 'Save the Daughter' and then advanced to the pledge of 'Educate the Daughter'. Now is the time for 'Empower the Daughter'. Our aim is for every daughter to have a bright future and to fulfil her dreams — whether by becoming a District Magistrate, Chief Minister, sci-

entist, sportsperson, or any other role that brings honour and respect to the country.

On the occasion, Education Minister Ashish Sood recalled Netaji Subhas Chandra Bose's immortal slogan, "Give me your blood, and I will give you freedom," and remarked that today's India does not ask its

daughters for blood, but for their resolve, passion and unwavering determination. He said, "Flight is taken not with wings, but with courage." Sood also shared that the route for the 'Tiranga Cyclothon for Girls' once witnessed historic events such as the Dandi March.

At the special request of the Chief Minister, this event was organised exclusively for girls, just as Netaji had formed the Rani Lakshmbai Regiment during the freedom struggle. In another event, the Delhi CM joined Members of Parliament at the 'Har Ghar Tiranga' MPs Bike Rally, organised from Bharat Mandapam ahead of Independence Day. The rally, which commenced from Bharat Mandapam, aimed to inspire citizens to hoist the Tricolour at their homes and display it with pride.

# DTC electric buses to go for body wrap commercial advertisements

The electric buses of Delhi Transport Corporation (DTC) will soon be seen criss-crossing the city roads wearing colourful, body wrap commercial advertisements. The long-pending proposal of the DTC for extra revenue generation was stalled for years over road safety concerns raised by the Traffic police. "Now the DTC will provide 840 of its electric buses for whole body wraps to a concessionaire selected through

bidding for which tender has been floated," said a senior Transport department officer.

The DTC has also laid down rules to ensure no indecent or objectionable advertisements are displayed on the buses, he said.

As a part of an overall exercise to enhance revenues for DTC, it intends to grant permission to bus body wraps. The total number of 842 air-conditioned e-buses from nine depots are available for display of advertisement on the exterior.

The number of buses available for whole body wraps will increase in the coming



days, the officers said. Importantly, the proposal for the permission of advertisement on the right side of the buses is under consideration, said the tender document.

The DTC may consider granting permission to the successful bidder to advertise on the right side by charging an additional fee for the extra space, it said.

In future, if the fleet strength is increased, the concessionaire will have the first right of refusal to refuse advertisement on new buses, and it will be passed on to the next bidders, said the document.

in hotels that hold 1-15/L-15F licences. These licences are granted to star-classified hotels approved by the tourism department of the Government of India.

Such hotels are permitted to serve alcohol to their guests through room service, reflecting a balance between tradition and hospitality services. The excise department emphasised that this exemption is strictly limited to these licensed hotels and does not extend to other establishments.

Rule 52 of the Delhi Excise Rules, 2010, mandates the closure of liquor outlets on specified dry days to promote public order and respect significant cultural and national events. These regulations have been enforced by Delhi police and excise officials to ensure compliance.

The concessionaire will have to ensure that the advertisements are not "indecent, obscene and otherwise offensive" to good taste or against public sentiments or in contravention of the applicable laws, including MCD Bye Laws on advertisements, it said.

As such, negative advertisement contents like nudity, drugs, alcohol, cigarettes, tobacco, those propagating caste, community, ethnic difference, sexual overtones, among others, as well as advertisements banned by the Advertisement Council of India or by law, will not be permitted, it added.
